ISO 14001:2004 TO ISO 14001:2015 TRANSITION/ UNDERSTANDING

This training course aims to give a basic overview of the changes to ISO 14001:2015, resulting from the review and revision of the 2004 standard.

It introduces the requirements of an environmental management system based on the revised standard which supports the fundamental “environmental pillar” of sustainability, together with the key intended outcomes of a management system, including:

1. Enhancement of performance;
2. Conforming to compliance obligations; and
3. Fulfilment of objectives

ISO 14001:2015 UNDERSTANDING AND IMPLEMENTATION

The objective of the understanding and implementation training is to enable delegates to gain an understanding of the Environmental Management Systems (EMS) by providing delegates with an overview and knowledge of the requirements of ISO 14001:2015, transition and changes and this will ensure the delegate to be able to establish, implement, measure and monitor the Environmental Management system in line to the 14001:2015 requirements.

ISO 14001:2015 LEAD AUDITOR

This training course aims to develop the knowledge and skill required to conduct a full audit of an organization's Environmental Management System (EMS) to ISO 14001:2015.

Training Course Outcomes

- Describe the purpose of an environment management system (EMS);
- Explain the principles of environmental management on which the ISO 14000:2015 series of standards are based;
- Explain the purpose, content and interrelationship of ISO 14001:2015 and ISO 19011:2012;

- Describe the roles and responsibilities of auditors and lead Auditors;
- Plan and conduct an audit in accordance with ISO 19011:2012 and demonstrate the ability to Plan and Prepare effectively;
- Gather objective evidence, through effective interviewing, observations, sampling and note taking;
- Analyse and interpret information in order to determine conformance with requirements;
- Report the audit, including writing valid, factual and value adding non conformities reports; and
- Undertake audit follow-up activities including evaluating the effectiveness of nonconformity and corrective action.
